# 6. COMMISSIONERS

- a. Precinct 3 Discuss and consider approval to accept the GROUND LEASE AGREEMENT between Gregg County and Sabine Independent School District on the 2.766 acres of land located in Liberty City and owned by Gregg County.
- b. Precinct 3 Discuss and consider approval to relocate and spread topsoil (approximately sixteen yards) from Sabine Independent School District's High School football stadium area to their elementary campus soccer field located at 645 Access Road in an effort to reduce injuries caused by the current fields iron ore dirt. Precinct 3 will provide the labor and equipment to move the topsoil and spread evenly across the field. Project Planning Report is provided.
- c. Precinct 3 approval and any necessary action to add re-oiling of Tubbs Road, Wrong Road, and Carr Road back to the FY23 project list. Budget funds are available and Project Planning Report is included.
- d. Precinct 4 Discuss and consider approval for a culvert installation at 230 D Holland Road, Kilgore, Texas. Property Owners will purchase forty feet (40') of twelve-inch (12") diameter black plastic culvert for the location. Precinct 4 will provide labor, equipment and recycled asphalt for fill-in.
