#### **MINUTES**

### **Gregg County Historical Commission**

#### May 6, 2002

The Fortieth Annual Meeting of the Gregg County Historical Commission met on Monday, May 6, 2002, in accordance with Texas Open Meetings Act: Section 551, Texas Government Code, article 6252, *Vernon's Texas Civil Statutes*. The Commission met in the Education Center of the Gregg County Historical Museum.

Commission Chair, Dr. Norman Black, called the meeting to order at 10:00 a.m., noting that for the first time in recent memory all members of the Commission were present for the annual meeting. Those in attendance were Sue Brown, Jack Buchanan, Pauline Cox, Ann Crain, Beth Dodson, Helen "Pudge" Griffin, Carol Little, Virginia Long, Anne Mackenzie, Nauty Byrd Mayer, Amanda Nobles, W. D. Northcutt, Elizabeth Osteen, Harold Wells, Joe White, and W. A. Williams. Dr. Black welcomed Nancy McWhorter, Director of the Gregg County Historical Museum, and he congratulated Pudge Griffin, who was elected Citizen of the Year in Kilgore, and Sue Brown, who was chosen First Lady of Kilgore.

Minutes of the May 1, 2001, meeting were approved as amended by the addition of Joe White's name among those attending.

Dr. Black announced the creation of a new committee suggested by the Texas Historical Commission. Members of the new Endangered Properties Committee are Carol Little (chair), Pudge Griffin, Harold Wells and Norman Black.

#### **REPORTS**

#### Museums

Gregg County Historical Museum: Nancy McWhorter announced that a new traveling exhibit, "George Washington: Architect," will be on display at the Museum for one month beginning June 21, 2002.

East Texas Oil Museum: Joe White reported that plans are underway for the celebration of the Museum's twenty-fifth birthday in 2005. Tourists in ten busses from Chicago recently visited East Texas and toured the Museum. A chartered bus also brought visitors from Kansas City, Missouri,

Gladewater Museum: Nauty Byrd Mayer reported that Museum supporters have raised \$20,000 of the \$30,000 needed to apply for a grant. Artifacts are being collected and a site for the museum has been secured.

Rangerette Showcase and LeTourneau Museum: The report on these two organizations is unchanged from the last meeting, according to Dr. Black.

### School Awards Program

Beth Dodson said that projects currently are being collected and that Sabine Independent School District is a new participant this year.

### Walter Prescott Webb Society

This group continues to maintain the old Parmer Cemetery on Ray Street.

### Kilgore Historical Preservation Foundation

Sue Brown confirmed that fifty-two derricks have been erected, with 49 under the auspices of the Foundation.

#### CHAIRMAN'S REPORT

#### Markers Markers

Dr. Black reported that in 2001 Gregg County acquired an Official Texas Historical Marker for the Lewis-Bivins House. The owner, Peggy Bivins Reed was unable to come to Longview for an official dedication so the marker was placed on the twentieth-fifth of August without ceremony. A marker also was placed at Hunter's Cemetery. Markers awarded through the Family Farm Heritage Project are not the purview of the Commission, but the Commission keeps abreast of additions.

No markers are awaiting dedication. None is awaiting approval in Austin, none has been denied, and none has been damaged, stolen or vandalized. No marker has been replaced or refinished. A marker is pending on The Grove, an acre of land that John R. Magrill sold to the black citizens of Longview for forty dollars. A marker for the Longview Municipal Building and Central Fire Station currently is at the foundry. Ideas for future markers include the old Womack School site.

Street markers for Nugget Hill National Register District have been erected and the project is complete. The Northcutt House has been re-roofed and painted, and repairs have been made on the Dundee-Angus House.

#### ANNUAL MEETING OF THE GREGG COUNTY HISTORICAL COMMISSION

One Official Texas Historical Marker was erected in Gregg County in the last twelve months. It is for the Longview Administration Building and Central Fire Station at 100 E. Cotton Street in Longview. The dedication was held for the 1936 structure on November 1, 2002. Also, a marker for "The Grove", where Magrill Plaza is located at N. Green, Padon, First and Grove Streets, is in the process of being cast at the foundry.

This announcement was made by Dr. Norman Black, Chairman of the Gregg County Historical Commission at the forty-first annual meeting of the Commission held in the Education Building of the Gregg County Historical Museum Monday, May 5, 2003.

Each year the commission recognizes one outstanding student from each of the middle schools in the county with an Award of Merit Certificate. Beth Dodson, chairman of this committee, said several school officials have submitted names of seventh grade students who excelled in Texas history during the school year.

The Junior Historian chapters in the county schools continue to be active in their projects. The Webb Society at LeTourneau University has as their project the maintenance of the Parmer Cemetery, a small wrought-iron fenced cemetery with the last burial date of 1885.
