John Landrum Finch d. Aug. 23, 1911, Longview, Tex. He was named for the Rev. John Landrum who united in marriage Matilda Durham and Andrew Coan Hoy. He removed to Hallville, Tex. where he (John L. Finch) had a harness and saddle shop. He brought with him a Melodeon which is now ownded by his granddaughter, Elaine Markham (now wife of Dr. Reid Clanton). In 1872 he came to Longview where he united with the recently organized First Baptist Church, continuing his membership there throughout his life. He became a Mason when a resident of Spartanburg, S.C. He served in the Confederate Army during the War Between the States.

John L. Finch was the son Mary Ann Coan, b. Aug. 28, 1806, Spartanburg, S.C. and John Smith Finch, b. Oct. 22, 1804, Spartanburg. They mar. Jan. 26, 1826, Spartanburg. Her mother was born in Ireland and he of English descent.

Dear Mr. Audet:

I am pleased that you are now living in the Finch House. It is one of my favorite historic structures in Gregg County, also, it means a lot to me personally as Eva Jean and I were in the Longview schools since the fourth grade (for me) in 1936. Mr. and Mrs. Finch were very fine and likeable people.

As you probably know, the house is an Early Victorian cottage with gingerbread trim and has many chimneys. The most unique features of the design are the two front rooms that open onto the front porch and not directly into the house. One was used for travelers for overnight visits and the other as an office. Either Mr. John Finch or Eva Jean told me Mr. Finch, as as boy, sort of dreaded the times when the visiting preacher came by because his father always had him (John) unhitch the horses from the buggy and tend to them in the back yard.

I hesitate to drive up the inspect the historical marker, which cannot be seen from the road, but I believe someone would inform me if it needed attention. Several years ago the marker was attached to a previous wood picket fence and was about to fall off. I sent it back to the foundry to have it mounted on the post and it is sunk, not very deeply, onto solid rock. We could not get through the hard rock to set it the 33 inches normally done. It's pretty strong as it has concrete around the post for a couple of feet, as I remember. Of course, I know a few more personal events about the place and have some information on the Finch genealogy but Eva Jean is a much better source.
