

Notice About 2025 Tax Rates

Property tax rates in Gregg County.

This notice concerns the 2025 property tax rates for Gregg County. This notice provides information about two tax rates used in adopting the current tax year's tax rate. The no-new-revenue tax rate would impose the same amount of taxes as last year if you compare properties taxed in both years. In most cases, the voter-approval tax rate is the highest tax rate a taxing unit can adopt without holding an election. In each case, these rates are calculated by dividing the total amount of taxes by the current taxable value with adjustments as required by state law. The rates are given per \$100 of property value.

This year's no-new-revenue tax rate	\$0.279087/\$100

Voter-Approval Tax Rate Adjustments

State Criminal Justice Mandate

The Gregg County Auditor certifies that Gregg County has spent \$649,827 in the previous 12 months for the maintenance and operations cost of keeping inmates sentenced to the Texas Department of Criminal Justice. Gregg County Sheriff has provided Gregg County information on these costs, minus the state revenues received for reimbursement of such costs. This increased the voter-approval tax rate by 0.000648/\$100.

Indigent Health Care Compensation Expenditures

The Gregg County spent \$2,958,580 from July 1, 2024 to June 30, 2025 on enhanced indigent health care at the increased minimum eligibility standards, less the amount of state assistance. For the current tax year, the amount of increase above last year's enhanced indigent health care expenditures is \$243,057. This increased the voter-approval tax rate by 0.001908/\$100.

Indigent Defense Compensation Expenditures

The Gregg County spent \$1,048,725 from July 1, 2024 to June 30, 2025 to provide appointed counsel for indigent individuals, less the amount of state grants received by the county. In the preceding year, the county spent \$1,038,516 for indigent defense compensation expenditures. The amount of increase above last year's indigent defense expenditures is \$10,209. This increased the voter-approval rate by 0.000080/\$100 the increased expenditures.

This notice contains a summary of actual no-new-revenue and voter-approval calculations as certified by Michelle Terry, Gregg County Tax Assessor Collector on 07/30/2025 .
