THIS AGREEMENT, made and entered into this 26th day of March, A.D. 2019, by and between the County of Green, and State of Texas, acting through its County Judge, thereunto duly authorized so to do, Party of the First Part, hereinafter termed OWNER, and Casey Slone Construction. LLC of the City of Marshall. County of Harrison, and State of Texas, Party of the Second Part, hereinafter termed CONTRACTOR.

WITNESSETH: That for and in consideration of the payments and agreements hereinafter mentioned, to be made and performed by the Party of the First Part (OWNER), and under the conditions expressed in the bond bearing even date herewith, the said Party of the Second Part (CONTRACTOR), hereby agrees with the said Party of the First Part (OWNER) to commence and complete the construction of certain improvements described as follows:

and all extra work in connection therewith, under the terms as stated in this Standard Form of Agreement; all of the documents attached to this Standard Form of Agreement; all Plans, Specifications and drawings for the project as prepared by the OWNER's engineer Hayes Engineering, Inc. (herein entitled "ENGINEER"); and all printed or written explanatory materials of said Plans, Specifications and drawings. The CONTRACTOR hereby agrees with the OWNER that the CONTRACTOR shall commence and complete all such construction and work at the CONTRACTOR's own proper cost and expense to furnish all the materials, supplies, machinery, equipment, tools, superintendence, labor, insurance, and other accessories and services necessary to complete the said construction and work.

The documents that are attached to and for all purposes made part of this Standard Form of Agreement include Addendum No. 1, the Notice to Bidders, Instructions to Bidders, Conflict of Interest Form, Statement of Qualifications, Certification of Eligibility, CONTRACTOR's Bid Proposal, Bid Signature Form, Bid Bond, Certificate of Interested Parties (Form 1295), Construction Performance Bond, Construction Payment Bond, Maintenance Bond, Certificate of Insurance, Separation of Materials Form, Certificate of Final Completion, Gregg County, Texas Standard Terms and Conditions, Wage Rate Determination, General Conditions, Special Conditions, and Technical Specifications. This agreement shall also include all Plans, Specifications and drawings for the project, as prepared by the ENGINEER, and all printed or written explanatory materials of said Plans, Specifications and drawings. This Standard Form of Agreement and the documents listed herein shall collectively evidence and constitute the entire contract between the parties hereto regarding the subject matter hereof.

The CONTRACTOR hereby agrees to commence work within ten (10) days after the date written notice to do so shall have been given to him, and to complete the same within <u>Ninety</u> (90) calendar days after the date of the written notice to commence work, subject to such extensions of time as are provided by the General and Special Conditions.

CONTRACTOR's failure to timely commence work or diligently pursue completion of the work within the time limitations set out herein shall constitute a material breach of this contract. TIME IS OF THE ESSENCE IN THE PERFORMANCE OF THIS CONTRACT.

The OWNER agrees to pay the CONTRACTOR in current funds the price or prices shown in the Proposal, which forms a part of this contract, such payments to be subject to the terms and conditions of this contract, including without limitation the General and Special Conditions of Agreement. Without regard to and notwithstanding any rules on conflicts of law, this contract shall be subject to and interpreted in conformance with the laws of the State of Texas, unless expressly required otherwise by federal law or regulations.
