- Lisinopril is not the generic equivalent of Accupril. Do you wish for bidders to provide prices for the generic equivalent of Accupril? Or, do you wish for bidders to provide prices for Lisinopril?

Regarding the Gregg County Sheriff's Department price list on pages 22-23 of the RFP:

- Are you requesting pricing for both the brand name and generic medications on the list?
- ➤ Both, please follow the RFP instructions.
- Are you seeking a price for one (1) syringe of Narcan or for 10 syringes? (1 syringe)
- Are you seeking a price on one (1) vial of Phenergan or for 25 vials? (Both)
- Are you seeking a price on one (1) vial of Haldol or for 10 vials? (10 Vial)
- Are you seeking a price for one (1) vial of Lantus or for 1 mL of Lantus? (10 mL vial)

As the County reserves the right to award multiple contracts in the best interest of the County (STANDARD TERMS AND CONDITIONS, item 25 on page 8), will the County accept and consider proposals submitted by vendors who wish to service the Sheriff's Department and Juvenile Facility, but not the Health Department?

➤ The County will review all proposals submitted.

How are controlled substance medications destroyed, as they cannot be returned? Biohazard

How do your facilities handle hazardous and non-hazardous pharmaceutical waste in compliance with August 2015 EPA regulations?

Approved Bio-hazardous waste company picks up and destroys all waste.

Could you provide your current medication formulary as an addendum, so bidders can review it for possible modifications or recommendations?

- > Does not utilize a formulary
- ➤ Health department does not use a formulary at this time

Can you provide, as an addendum, copies of your three most recent pharmacy invoices that include actual pharmacy utilization data (without patient names) for each the Sheriff's Department, the Health Department, and the Juvenile Facility?

This information (medication cost and utilization) usually is considered public record and this data would be very helpful to bidders in the preparation of a competitive bid rate when actual utilization is known by all bidders versus having to project utilization if this data is not disclosed and only known by your incumbent provider.

What state and federal licenses are in each facility's name? None

Does each facility have a state pharmacy or clinic license? None

Does each facility have a U.S. Drug Enforcement Administration (DEA) registration, which is required to receive stock controlled substances (i.e., Schedule II-IV medications)? If not, is the physical address of each facility listed as the business address on the DEA license of at least one of your facility's providers for each facility? Yes

Nearly every correctional facility nationwide has some degree of emergency, night-locker, or first-dose starter stock on hand. Facilities often overlook that a pharmacy provider cannot dispense more than 5% of their overall company-wide sales as stock. (Federal Register, Vol. 64, No. 232, 21 CFR Parts 203/205, III, H, 4.) A vendor is required by The Texas Administrative Code Title 25, Part 1, Chapter 229, and the Texas Department of State Health law to be a licensed wholesaler in Texas to distribute wholesale quantities of stock medications in Texas. Therefore, to comply with federal and state regulations, a pharmacy provider must be a licensed wholesaler or use the services of a wholesaler licensed in both their home state and in Texas to distribute wholesale quantities of stock medications.

- Will you require bidders to include documentation in their proposals to show whether they are licensed as a wholesaler or whether they use the services of a Texas-licensed wholesaler?
- Please follow RFP instructions.
- Will failure to provide proof of compliance with state and federal regulations, specifically this requirement, deem a pharmacy bidder as non-responsive and therefore ineligible for an award (per STANDARD TERMS AND CONDITIONS, item 9 on page 6 of the RFP)?
- No, not necessarily however, the County will make these official decisions should such a situation occur. The County reserves the right to retrieve information from prospective bidders as needed.

A company must be a FDA-registered repackager to legally repackage stock medications into blister cards or any other packaging that results in a change to the original manufacturer's packaging.

- Will you mandate that the pharmacy vendor use an FDA-registered repackager if stock is provided in packaging other than the original manufacturer's packaging?
- ➤ Vendors are expected to follow the Law in respect to their business.
- Will failure of a pharmacy bidder to comply with FDA repackaging regulations regarding the provision of stock deem that bidder non-compliant and therefore ineligible to receive an award (per STANDARD TERMS AND CONDITIONS, item 9 on page 6 of the RFP)?
- No, not necessarily however, the County will make these official decisions should such a situation occur. The County reserves the right to retrieve information from prospective bidders as needed.

Will you mandate that the pharmacy vendor be a National Association of Boards of Pharmacy (NABP) Verified-Accredited Wholesale Distributor (VAWD)? Will you require documentation to be submitted as part of the proposal?

Title II of the Drug Quality and Security Act (DQSA) requires prescription drug data be tracked throughout the supply chain. Wholesalers **and pharmacies** (providing stock under the 5% rule) that provide stock to correctional facilities must collect and store information provided by manufacturers, identifying drug products to the lot level in the form of paper or electronic transaction history records -formerly known as pedigree documentation.

Do your facilities currently use an electronic prescription order entry and eMAR system that is provided to you at no cost by your current pharmacy vendor? No

Do your facilities currently use a barcode-enabled electronic order reconciliation and medication return management system that is provided to you at no cost by your current pharmacy vendor?

Do your facilities currently have 24/7/365 access to a web-based online reporting dashboard provided at no cost by your current pharmacy provider for you to access meaningful and accurate reporting? Yes
